- 1. Rodney is a member of an unusual religious group with some very different beliefs.

 When he attempts to enlist in the army, the recruiting officers refuse to accept his application because they do not want members of this group in the army.
- 2. ____ When Sandra is on trial for murder, her defense lawyers find out that the district attorney never got an indictment from the Grand Jury saying that there was enough evidence for a trial to be held.
- 3. Henry is ticketed for driving 10 miles-an-hour over the speed limit. When he goes to the courthouse to pay for his ticket he is told that the fine will be \$9000.00!
- 4. Jessica goes on trial for attempting to steal a car. When a statement that she made to the arresting officer is entered as evidence, her defense lawyer proves that no officer ever read her basic Constitutional rights to her when she was arrested.
- 5. Salvador is arrested when traffic patrol officers find an illegal type of gun in the trunk of his car. He never gave them permission to look in the trunk and they never produced a search warrant to look in the trunk.
- 6. ____ Helen's lawyer wants the judge to force a boyfriend of Helen's to come to court to testify that Helen was never at the scene of a crime that she is accused of committing. The judge replies that if Helen's friend wants to come to court he can, and if he doesn't, then the trial will have to proceed without him.
- When the police arrive at Lawrence's house they have a search warrant and they begin looking for evidence that he is a drug dealer. As they search, they find a gun that is legally registered to Lawrence, and is a legal firearm. Even though he has no criminal record and they find no evidence of drug dealing; they take the gun away because they say that they do not trust him with it.

Freddy says he wants a lawyer to tell him what he should say and what he shouldn't say; but the police tell him he isn't on trial yet and that he can't have a lawyer until such time as he is on trial.
- 10. ____ Congress attempts to pass a law that says-starting in 1995 only the federal government will be able to issue drivers licenses for all people who operate cars in the United States.

Suddenly, the police arrive and tell her friends that they will have to leave because the mayor thinks that they might be trying to get voters to vote against him.
- 16. ___ Omar, a Muslim (religion) fundamentalist is accused of bombing a Jewish synagogue (church). He is convicted and sentenced to prison. But, later it is found that all twelve members of the jury were Jews.
- 17. Luwanda was the owner of the last piece of property that the state needed to buy in order to finish a section of freeway. Luwanda tried for years to avoid selling her property to the government and when she lost her lawsuit, the state agents only paid her about half of what they had paid other property owners for their identical pieces of property. They said that this would "teach her a lesson".
- Stanley was accused of committing a gruesome murder in his small hometown.
 When he was taken to court for a reading of the charges against him, the judge told him he was going to be tried in a nearby city, because his hometown could not afford to put on a large, expensive trial.
